# GOVERNANCE




The Foundation is governed by a Board of Trustees and is managed by an Executive Committee on which all partner entity executives are represented.

## KST

KST is a collaboration partnership between Kagiso Trust and Cyril Ramaphosa Foundation that was established in 2013.

KST leverages the strategic, technical and best practices of Kagiso Trust's and Cyril Ramaphosa Foundation's respective Whole School Development programmes to address school infrastructure, curriculum support, social welfare and school leadership on a district-wide basis. The pilot programme was implemented on a match-funded basis with the Free State Department of Education at all schools in the Fezile Dabi district and at select schools in the Botshabelo and Thaba N'chu municipalities in the Motheo district.

The KST model is currently being rolled out in partnership with the Anglo-American School Advancement Programme at 110 additional schools in Mpumalanga, Limpopo and the Northern Cape.





## **THARI** P R O G R A M M E

Thari's goal is to strengthen the school community by creating a safe and empowering environment that is free from violence, academically effective, inclusive, gender sensitive and that promotes health and well-being for all.

## **THARI** Programme

The Thari Programme for the support of women and children was launched in 2017 to address socioeconomic challenges that affect learners and impact learning outcomes.

The pilot project is implemented by the Foundation's partner entity, Adopta-School, in school communities in Botshabelo in the Free State and Diepsloot in Gauteng.

Thari's goal is to strengthen the school community by creating a safe and empowering environment that is free from violence, academically effective, inclusive, gender sensitive and that promotes health and well-being for all.

The programme was developed in response to a variety of community challenges that impacted on learning outcomes:

- Gangsterism among children and adults.
- Alcohol and substance abuse
- Teenage pregnancies;
- Dysfunctional families and high prevalence of Gender-based Violence
- Orphans and child-headed households.

# THARI PROGRAMME'S **STRATEGIC PILLARS**



#### **PSYCHOSOCIAL SUPPORT SERVICES**

- Through the services of Youth and Child Care Workers.
- To address emotional problems, sexual abuse, neglect, other forms of abuse and poverty related issues.



#### SAFE PARKS

- A therapeutic space for vulnerable children requiring psychosocial support services and a safe after-care facility.
- To address the lack of interest, lack of discipline and absenteeism through recreational facilities and life skills programmes at the Safe Park.



#### MULTI-SECTORAL MODEL

- A harmonised approach to address social factors that make women and children vulnerable, especially gender-based violence.
- To address gangs, substance abuse and bullying through dialogue sessions in collaboration with with multi-sectoral forums.



## THEORY OF CHANGE

The Thari Programme's Theory of Change outlines the goal of the programme, (including both the long term and intermediate outcomes), how they will be achieved through the selected model, core activities, interventions, knowledge and change indicators.



### **ULTIMATE GOAL**

Strengthen the school community by creating a safe and empowering environment that is free from violence, academically effective, inclusive, gender sensitive, and promote health and wellbeing for all.

#### LONG TERM OUTCOMES

An empowered school community with access to services, and a safe school.

Psychosocial well-being and resilient children, and school accessing child protection services.







To identify and recruit candidates that display potential and overall leadership qualities, as opposed to only academic excellence.






